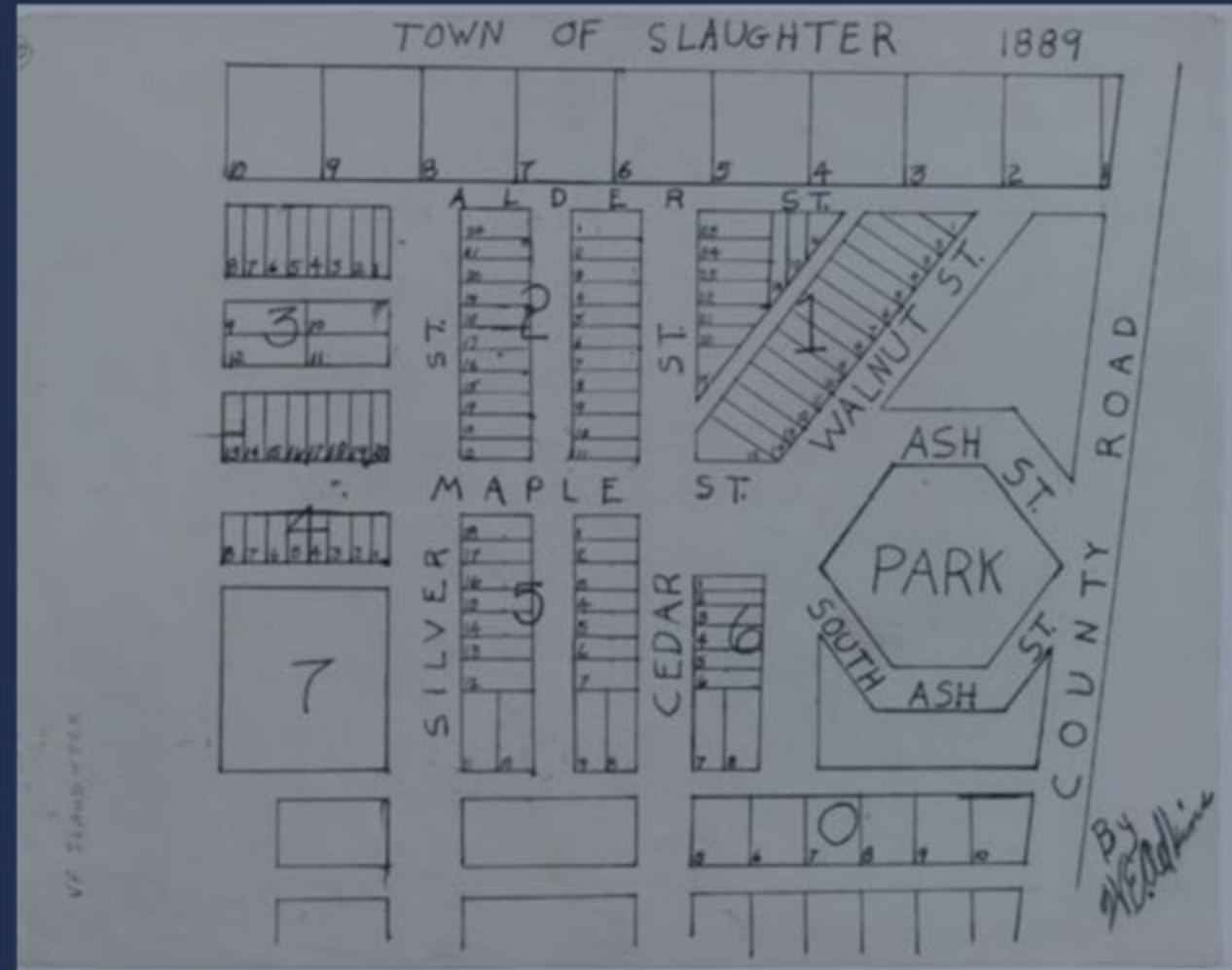

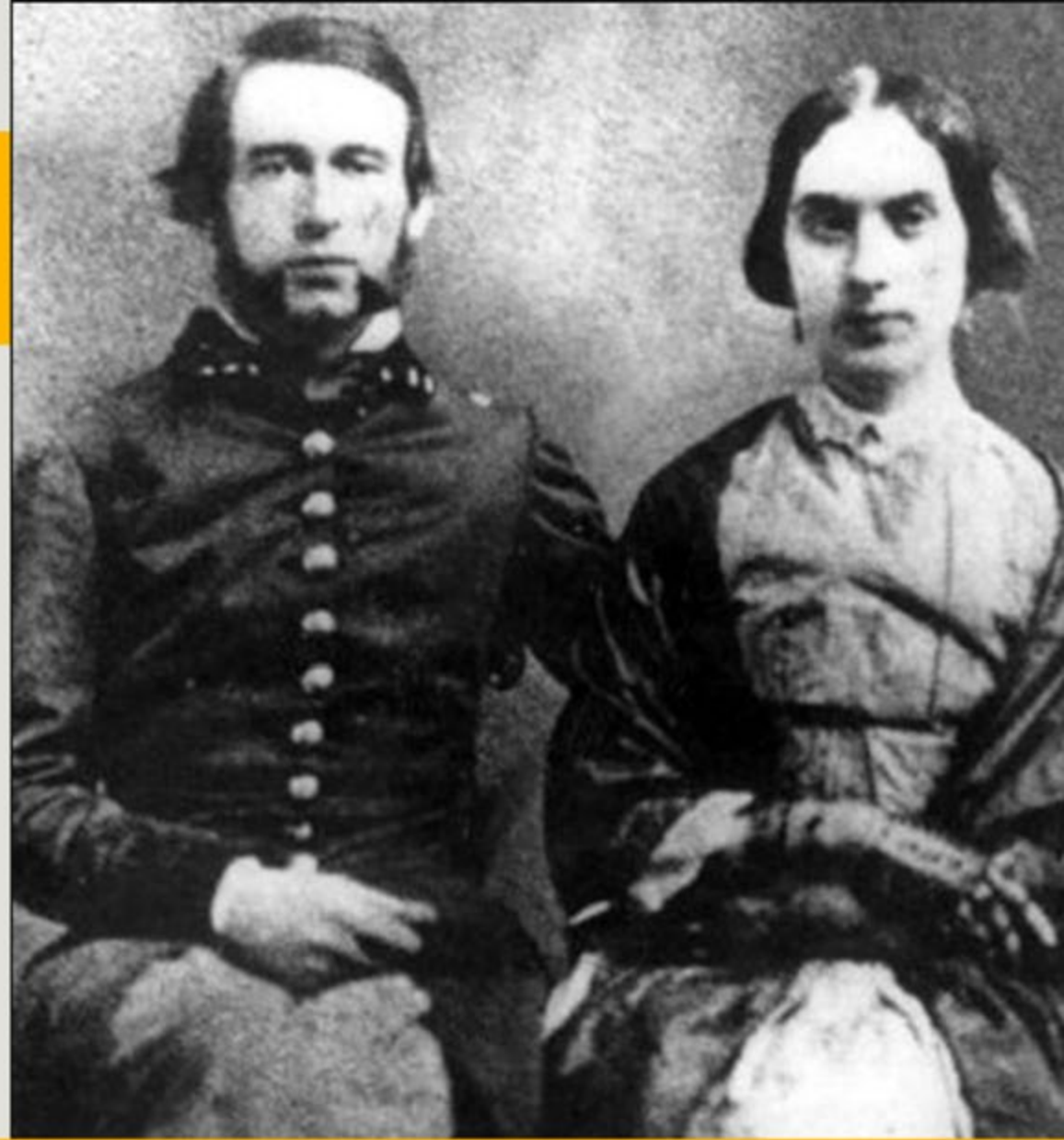

Before Auburn

- Auburn is located near the original confluence of the Green and White rivers, both of which contain runoff water from the Cascade Mountain range.
- The valley was originally the home of the Skopamish, Smalhkamish, and Stkamish Indian tribes.
- The first white men in the region were explorers and traders who arrived in the 1830s.
- The **Muckleshoot Indian Reservation was established in 1857**
- The Tribe is a federally recognized Indian tribe whose membership is composed of descendants of the Duwamish and Upper Puyallup people who inhabited Central Puget Sound for thousands of years before non-Indian settlement.
- The Tribe's name is derived from the native name for the prairie on which the Muckleshoot Reservation was established.

Town of Slaughter?

- Incorporated in 1891, Auburn was originally named **Slaughter** after Lieutenant William Slaughter
- **Renamed to Auburn** in 1893
- The name was taken from the first line of Oliver Goldsmith's poem, *The Deserted Village*: "Sweet Auburn! Loveliest village of the plain." (*Or stolen from New York?*)



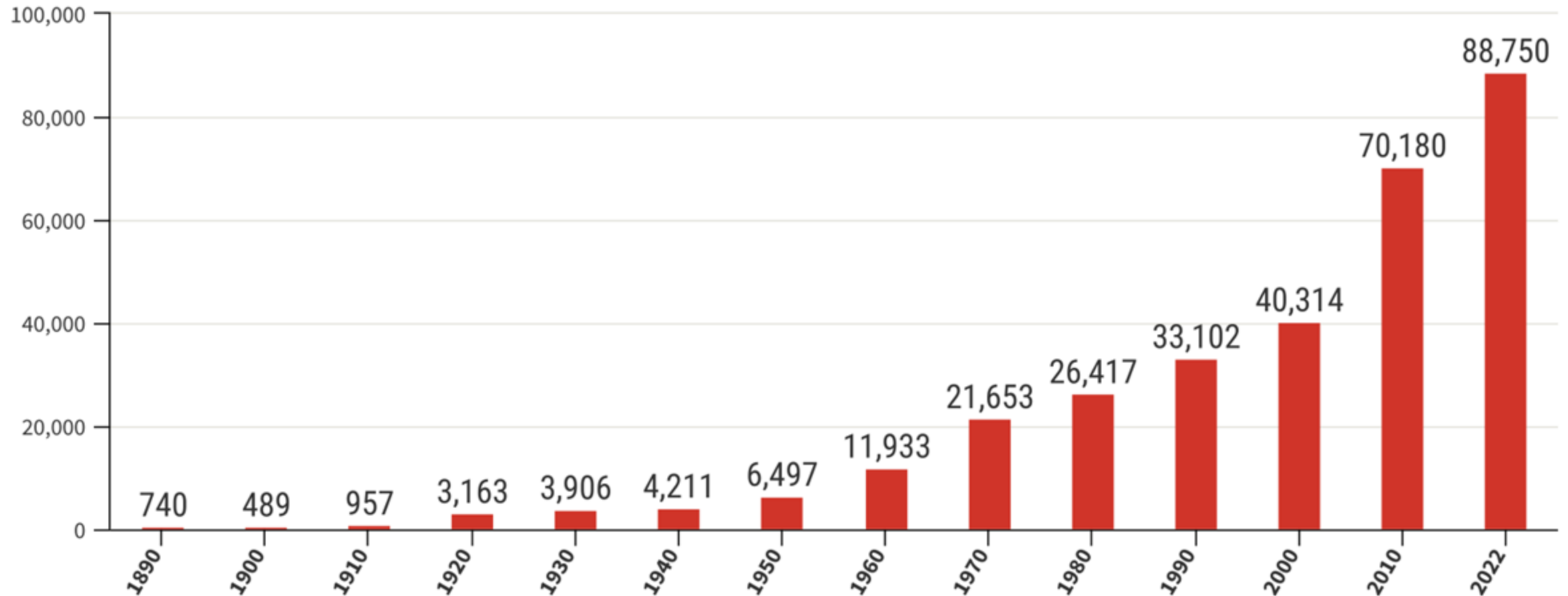

Commission

- The City of Auburn functions under the **Mayor-Council** form of government
- The mayor-council form consists of an elected mayor who serves as the city's chief administrative officer, and a council which serves as the municipality's legislative body.

**The mayor-council form of government is the most common in Washington state with 227 of our 281 cities (60%).*

City Council Duties

The Council is responsible for:

- Setting policy
- Adopting the biennial budget
- Adopting laws
- Determining the services to be provided and the funding levels for those services
- Confirming members to advisory boards and commissions

City Council Duties

In the course of duties, Council members will:

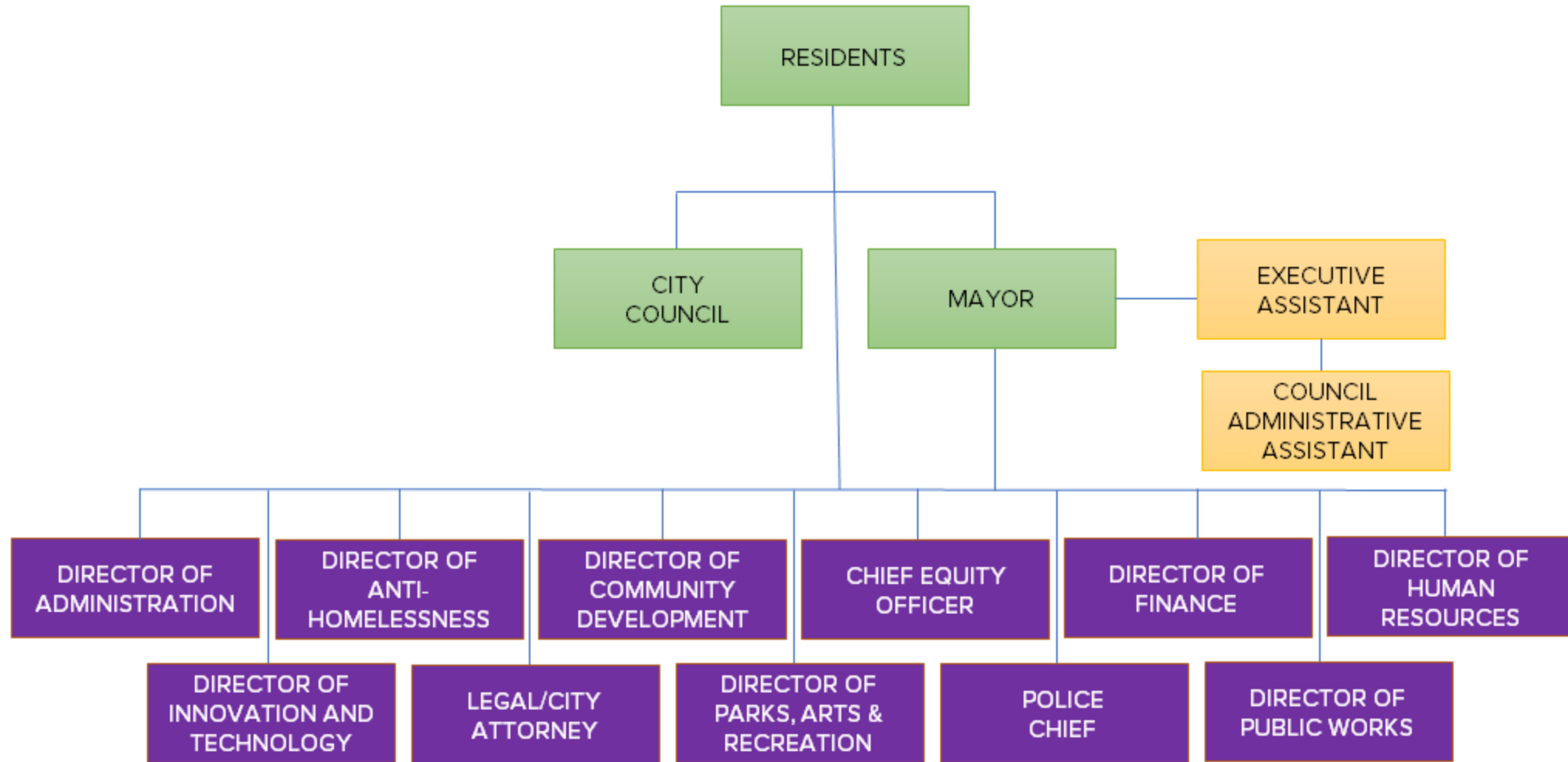
- Be a member of a special focus area
- Select a Deputy Mayor
- Engage with various departments, staff, and the Mayor
- Represent Auburn in regional initiatives and organizations

City Council Duties

General time commitment:

- Four council meetings per month (2 hours or more per meeting)
- Serving on regional committees and policy boards (2-4 hours per month or more)
- Some travel is expected locally, regionally, and at times nationally
- Monthly Council Member salary as of July 1, 2023 will be \$1,555.20 per month and Deputy Mayor will be \$2,073.60 (no benefits)
